

If you want to rent a property listed for rent by Harcourts Grenadier Accommodation Centre, then you need to fill in this form.

- An Application Form needs to be completed for every adult who will live in the property if the Application is successful. You must complete all sections of the form, and by signing below you declare that all information provided is true, accurate and correct. Any false, misleading, or missing information may result in your Application being declined.
- Your Application should be delivered in person to our office at **Level 1 Grenadier House, 98 Moorhouse Avenue**; posted to P O Box 36-360, Merivale, Christchurch 8146; or emailed to letting@assetmanagers.co.nz. We will do our best to respond to your Application within 2 working days from the time it is received.
- Submission of a completed Tenancy Application Form does not constitute acceptance of any offer to rent. Confirmation of a tenancy requires the signing of a separate Tenancy Agreement and other tenancy documentation.
- If this Application is approved, then the Tenant acknowledges that a Letting Fee of one weeks rent (plus GST) is due and payable to Grenadier Accommodation Centre Limited along with the first weeks rent, and the Bond, on the day of signing the Tenancy Agreement. The Tenancy Agreement must be signed within 1 working day of approval. Payment is to be by Electronic Bank Transfer or Bank Deposit.
- There may be other people submitting applications to rent the same property. When deciding on the best application for a property a number of factors are taken into account, but the commencement date, length of tenancy and weekly rent offered carry special consideration. For example, an Application at the full rent commencing on the first day a property is available will be preferable to one starting four weeks later.
